MUNICIPALITY OF THE COUNTY OF PICTOU MUNICIPAL PLANNING STRATEGY AND LAND USE BYLAW PUBLIC HEARING

TAKE NOTICE that on **Monday, May 5 at 6 p.m.** the Municipal Council for the Municipality of the County of Pictou will hold a Public Hearing on its Municipal Planning Strategy (MPS) and Land Use Bylaw (LUB) for the entirety of the Municipality. The hearing will take place in Council Chambers at 46 Municipal Drive, Pictou.

The Municipal Planning Strategy (MPS) is the primary planning document for the Municipality which establishes the vision, goals and policies for growth and development. It is the roadmap that helps to guide decision making relating to what we build, where, and at what intensity. An MPS looks at many different aspects of life in the community including (but not limited to) housing, economic development, agriculture, drinking water, and infrastructure.

The Land Use Bylaw (LUB) is the companion document to the MPS, and puts the vision, goals, and policies into action through specific regulations that have to do with development activities. The LUB sets out things like the land-use zones, permitted uses for these zones, standards for development, performance standards, developments to be considered by development agreement, developments to be considered by site plan approval process, among other things.

Anyone wishing to speak at the Public Hearing should register by contacting **sueann.musick@munpict.ca** or by **phoning 902-485-2238**. Presenters will be given 5 minutes to address their concerns to the Council.

Residents can also submit written comments for Council's consideration. Comments may be submitted in writing to the Municipality at PO Box 910, Pictou, Nova Scotia, or by email to **sueann.musick@munpict.ca**. **The deadline to receive written submissions is Monday, April 28, 2025, at 4 p.m.**

Residents of the Municipality wishing to view the MPS and LUB in its entirety can do so at the Municipal Administration Building, 46 Municipal Drive, Pictou, N. S. during regular business hours (8:30 a.m. - 4:30 p.m.) or on our website at www.munpict.ca



Landfill vouchers available May 1

Landfill Vouchers from the MOPC are available from May 1st until the end of November. Vouchers are given free of charge to people who own homes or cottages in rural Pictou County. Vacant landowners, wood lot owners, etc, do not qualify for such vouchers. Eligible residents can get up to four vouchers which each cover the tipping fee for up to 250 kg of garbage at the Mount William Transfer Station.

We ask that residents please be patient as vouchers cannot be printed prior to the May 1st date.







MOPC Alert




MOPC Alert was created as a tool for the Municipality to connect with residents to send important information prior to, during and after adverse weather events, or other EMO related information.

MOPC Alert is used to send our residents alerts about upcoming severe weather, comfort center locations and operating times, as well as any other information residents should be aware of such as public hearings or public engagement sessions.

Imagine MOPC is a project to develop a Municipal Planning Strategy (MPS) and Land Use Bylaw (LUB) for the Municipality of Pictou County.

Currently, there is no land use planning in MOPC with the exception of the Wind Energy Bylaw and the Subdivision Bylaw. In 2018, the Provincial Government passed new legislation that requires every municipality to adopt land use rules that meet newly established minimum planning standards. The Imagine MOPC project will bring the municipality into compliance with this provincial mandate. To learn more visit

The goal of the Switch MOPC Program is to make home energy upgrades simple and financially accessible.

Participants receive support from a personal Energy Concierge, who guides them through every step—helping with contractor selection, project planning, and navigating the financing process to ensure a smooth experience. The program offers financing to remove the barrier of upfront costs. The program pays contractors directly, allowing homeowners to repay through small monthly payments over 10-15 years. BurnSafe 101

The BurnSafe map is your guide to when it's safe to burn in Nova Scotia during wildfire season, March 15 to October 15.



 **GREEN** = burning is allowed after 2 pm.

 **YELLOW** = burning is allowed after 7 pm.

 **RED** = no burning is allowed.

Burning is never allowed from 8 am to 2 pm during wildfire season because that is often when the risk of wildfires is greatest. The map is **RED** during those hours. After 2 pm, check for an update.

Burn restrictions are updated daily at 2 pm based on weather data.



Check online at NovaScotia.ca/BurnSafe or call 1-855-564-2876 to see if burning is allowed.

You could be fined **\$25,000** if you do not follow Provincial restrictions
