Election 2024

The nominations are in and residents of Pictou County will soon be headed to the polls to choose their councillors in the 2024 Municipal Election.

All voting in the upcoming Oct. 19 election will be electronic. Voters will have the option to vote online or by phone. Voter cards and more information will be mailed out. Residents can expect this information to arrive by the first week of October. Those who do not receive a voter card by that time or would like to confirm they're registered to vote should contact the Returning Office at (902) 485-2253.

There will be two kiosks set up for those requiring assistance on Oct. 12, 2024, from noon to 8 p.m. and Oct. 15, 2024, from noon to 8 p.m. Kiosks will be set up at the Pictou County Wellness Centre and Scotsburn Fire Hall ONLY for anyone requiring assistance.

Residents will be able to cast their ballots starting at noon on Oct. 6, 2024, through 7 p.m. on Oct. 19, 2024. This can be done with any electronic device, phone or, for those requiring assistance, at a kiosk between the hours of 8 a.m. and 7 p.m. on Oct. 19, 2024.

Bridge reopens on Jitney Trail

The Jitney Trail's Gut Bridge is officially open. A grand opening ceremony for the bridge, which borders the Town of Pictou and Municipality of Pictou County, was held, Aug. 30, 2024.

The new bridge replaced one that was destroyed by a fire in 2022.

The project, which came at a cost of \$705,000 was made possible through a \$220,000 contribution from the Atlantic Canada Opportunities Agency (ACOA), as well as funding from the Province of Nova Scotia of \$200,000, the Municipality of Pictou County at \$100,000 and the Town of Pictou at \$185,000.

The trail bridge, locally known as the Gut Bridge, is a vital part of the trail system that ties Pictou to the larger regional and national networks, including the Trans Canada Trail, Nova Scotia's Blue Route cycling network, and the International Appalachian Trail.

"The loss of Gut Bridge was a blow to the community, but it also presented an opportunity to reimagine this essential link," said Central Nova MP Sean Fraser, Minister of Housing, Infrastructure and Communities. "The newly reopened bridge will provide safe, easy entry into the Town and County of Pictou for residents and visitors alike, increasing tourism opportunities and bringing more people to Pictou Waterfront and surrounding areas for years to come."

Built by Partners Construction, the new 130-foot freespan bridge features a durable metal structure with a coated steel deck and a 10-foot width. The free-span design, which eliminates any piers or obstructions in the waterway below, enhances navigation for small watercraft and improves the overall environmental sustainability of the site. Enhanced shoreline protection and improved materials ensure the bridge is resilient against future fire or damage.

"I am happy to see the beloved Jitney Trail Bridge, also known as the Gut Bridge, reopen to the public once again," said Pictou West MLA Marco MacLeod. "With the completion of construction, folks from Pictou and abroad can enjoy the scenic beauty and history of our community for many years to come."

The reopening of the bridge symbolizes more than just a crossing; it restores a community connection, reigniting the energy and accessibility of the Jitney Trail.

"The Jitney bridge replacement serves to strengthen the region's important trail infrastructure and provide renewed opportunities for active living", said Town of Pictou Mayor Jim Ryan. "We look forward to increased visitation to the area that will benefit the community and local businesses".

"The Municipality of Pictou County has always been a proud supporter of all organized trails in our rural Municipality. When the former gut bridge was destroyed by fire, although not legally in our Municipality, it was seen as a huge loss to many residents who used the Jitney Trail as a connector between our two municipalities. There was never a doubt that we would partner with the Town of Pictou and other senior levels of government to build a new bridge to restore this valuable connector. We are happy that the MOPC grants helped make this project a success. Many residents will benefit in both their physical and mental health because of the joint efforts of various governments, as it should be".

The Jitney Trail has always been a place where locals and visitors alike come together to experience the natural beauty and history of Pictou. The completion of this new bridge marks an exciting new chapter for the trail and the community it serves.

Coastal erosion and flooding

Coastal erosion occurs when the land along the coast wears away because of waves, currents, and tides. When storms are strong, they make erosion happen faster. For example, big storms like Hurricane Fiona cause more flooding and erosion along the coast.

People in Pictou County have noticed the coast is eroding more quickly now. Climate change makes this worse by causing bigger storms and reducing ice that protects the shoreline.

A Nova Scotia Environment and Climate Change report in 2022 advises that Pictou County will be one of the most vulnerable Nova Scotian counties to coastal and river flooding in the 2030s. For further information visit:

Historical rates of erosion have been measured, but not in a comprehensive way across Atlantic Canada. In the Northumberland Strait, erosion happens at different speeds depending on the land type. For instance, cliffs erode at 0.26 meters per year, while beaches erode at 1 meter per year.

Impacts

Erosion and flooding can damage roads, bridges, and homes. This can lead to job losses, problems with drinking water, and less recreational space. It also harms the environment by reducing the quality of water and increasing pollution.

To tackle these problems, MOPC plans to:

- Make a database to track floods, coastal changes, and river flows.
- Create an easy-to-use tool for property owners to check erosion and flooding risks.
- Change or add new rules to guide building in high-risk areas.
- Encourage people to take steps to protect their properties from flooding.



Introduction to Public Education on Climate Impacts

Recognizing the implications of climate change, in 2019 the Municipality of Pictou County (MOPC) Council formed a Climate Change Advisory Committee composed of County Councillors and citizen representatives.

In February 2022, the Council declared a Climate Change Emergency and committed to reducing its carbon footprint to net-zero and to assist its citizens, businesses, and community organizations reduce fossil fuel consumption. To follow through on this commitment, in July 2023 the Advisory Committee commissioned the preparation of a Municipal Climate Change Action Plan (MCCAP).


As part of the MCCAP development, the Advisory Committee is conducting a public education and engagement program. Over the next 5 weeks, MOPC will release information on the impacts of climate change on Pictou County, which will be followed by a series of townhall meetings to engage with interested citizens.

The proposed locations for the engagement meetings are Abercrombie Community Centre, Caribou Fire Hall, Durham Community Hall, Eureka Fire Hall, Hillside Community Hall, Little Harbour Community Centre, Merigomish School House Community Centre, and River John Legion. The Municipality of the County of Pictou currently has vacancies for the following nonelected volunteer positions:

Planning Advisory Committee (1 position)

2-year term, expiring March 31, 2026 The Committee is responsible for advising the Municipal Council, respecting the preparation or amendment of planning documents and planning matters generally.

Accessibility Committee (2 Positions)

2-year term ending March 31, 2026 The Accessibility Committee members provide input to municipal staff. members on setting priorities for accessibility to be responsive to the needs of people with various abilities. The Municipality strives to be welcoming, inclusive and accepting community to all people. Committee members will work to identify, remove, and prevent accessible barriers and meet the requirements of the Nova Scotia Accessibility Act.

Hector Arena Commission (1Position)

Two Year term, December 2024 - March 31, 2026 The Board is responsible for the management & operation of the Hector Arena.

Water Source Protection - Pictou (1 Position)

2-year term ending March 31, 2026

This advisory committee comprises elected and non-elected members from the Town of Pictou and the Municipality of the County of Pictou. Its objective is to take an educational and advisory role in protecting wellfields.

To be considered eligible for any of these committees, applicants must be residents of the Municipality and have lived there for a minimum of six (6) months. Applications should include a brief biography detailing any previous or related experience and skills that would be an asset to these positions, and applicants must supply three professional and/or volunteer-related references.
